- Divisions:** Competitors 15 years old and older and brown belt rank or higher may compete in their age/weight division and/or a senior division; competitors 30 years and older may compete in the Masters Category and /or Senior Category. A separate entry form and entry fee is required for each division entered.
- Eligibility:** Open competition. Contestants from all states are welcome. All contestants must be currently registered and insured with one of the following national organizations: USA Judo (NGB, USJI), USJF, or USJA (Membership in USA Judo will be available at the tournament site during registration). See below for age/weight eligibility. NGB cards will be on sale at weigh-in and registration.
- Insurance Note:** For insurance liability purposes, contestants must provide proof of current registration and insurance with one of the above listed national organizations. If the registration card is lost, New Mexico Judo Inc. can only verify USA Judo (USJI) registration locally.

Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.
4. Knowing the risks involved in the sport of Judo, I assume risk and accept personal responsibility for the damages following such injury permanent disability or death.
